- No correction/changes/amendment in the SSP will be valid unless the request for any correction/change/amendment is applied for and approved by the competent authority.
- This SSP is valid subject to fulfillment of all conditions of EXIM Policy, Customs Law, any other applicable allied Act, Notifications there under, relevant Rules, relevant Regulations, relevant Circulars etc.
- 6. This SSP shall remain valid till the permission holder carries on the activity for which it has been issued or surrenders it or till it is revoked / suspended by the competent authority. - 7. The grant of this permission shall be without prejudice to any other action that may be taken by such other agencies over the premises or purpose to which such agencies may require to enforce such laws to be complied by the Unit.
