**The terms and conditions are as follows:**

- 1) The stocks would be released in the presence of AP MARKFED representative, on a 100 percent weight basis at the weighbridges/weighing scale as stipulated by AP MARKFED and the same shall be considered as final.
- 2) Since the sale is on "ex-warehouse" and "as is where is" basis, all expenses such as labour charges, loading charges, weighment charges, etc. will be on the buyer's account.
- 3) GST and all other levies/tax as applicable would be extra and on buyers' account.
- 4) The invoice has to be raised for the difference in weighment for the empty lorry (tare weight) and loaded truck (Gross weight).
- 5) No pick and choose delivery at Ex-Wh/Godown will only be allowed.
- 6) The contracted quantity will be delivered as per RO subject to the availability of stock in the warehouse.
- 7) In case if the stock available in the allotted Warehouse is less than his eligible quantity, Markfed will return the amount remitted (without interest).
- 8) In case if the stocks are more than the eligible quantity, DM can permit the Buyer with prior permission on payment for the stock value, is allowed to lift.
- 9) The buyer has to complete the liftings of entire stock within 30 days from the sale confirmation dated:03-11-2021
- 10) With prior permission another 15 days lifting period is allowed on payment of rental /interest as per tender schedule. The penal interest and godown rent will be collected by AP MARKFED @ ₹5.00/Bag for Redgram/Maize/Jowar(50 Kg Bag) and @ ₹10.00/Bag for Turmeric(70 Kg Bag) 12 % of interest rate on outstanding and any additional taxes if any levied by the Government.
- 11) The District Manager is instructed to follow the guidelines mentioned in Tender document
- 12) The party is liable to pay interest & storage charges for the delayed payment & liftings.
- 13) No complaint of any nature regarding quality, weight, etc. would be entertained after-sale confirmation / Release since the sale is on "as is where is" basis. Parties desirous of inspecting the stocks may do so before participation in tender/ e-Auction. Any shortage/variation in weight at a later stage/in the party's godown shall not be considered.
- 14) AP MARKFED's responsibility shall cease once the goods leave the warehouse premises and no claim of quality, quantity and or any other nature, from the Buyer will be entertained thereafter.
- 15) AP MARKFED shall issue the Sale Invoice at the time of lifting of goods before the cargo leaves the warehouse.
